## **SHELVING INSTRUCTIONS**

Attached is the shelving affidavit. This affidavit applies to Master Electricians, Electrical Journeymen and Low Voltage/Limited Data Communication Technicians wishing to shelve his/her license.

### **MASTER ELECTRICIANS/LOW VOLTAGE/LIMITED DATA COMM. TECHNICIANS**

**The signed affidavit must be returned to this office by December 31.**

The fee for shelving your license is \$50.00 per year.

If received between January 1st – March 31<sup>st</sup>, there will be a late fee of \$25.

### **ELECTRICAL JOURNEYMEN**

**The signed affidavit must be returned to this office by September 30.**

The fee for shelving your license is \$50.00 per year.

If received between October 1st and December 31<sup>st</sup>, there will be a late fee of \$25.

Check or Money Order should be made out to the COMMISSIONER OF FINANCE.  
Cash is not accepted. Credit cards accepted in office only.

### **NOTE:**

Westchester Electricians who reciprocate with Putnam County do **NOT** need to shelve.

### **IMPORTANT!**

If you do not renew or shelve your license, your renewal privileges may be revoked.

*According to Putnam County Electrical Law, 145-10(H): Revocation of renewal privileges. Failure to renew a license issued under the provisions of this chapter within ninety (90) days after expiration thereof may result in the complete revocation of all renewal privileges hereunder. Any person desiring a license after such revocation of privileges may be required to reapply for licensure in accordance with the provisions of this chapter, including the payment of all applicable fees and successful reexamination.*

If you choose to shelve your license, you are not eligible to work in Putnam County. If you are found working without a license, you may be subject to a fine.

*According to Putnam County Electrical Law, 145-19 (G): Licenses can shelve in consecutive years for a maximum of five (5) years without Board approval. If the licensee wishes to extend shelving beyond five (5) years, the licensee must submit a letter to the board providing a satisfactory reason for continued shelving.*

**Beginning in 2019, any Master Electrician or Electrical Journeyman who shelves will be required to take a Continuing Education Class (CEU) for each year of shelving. Certificates issued by the CEU provider will provide proof of completion of the required class. Copies of these certificates must be included in any renewal or reactivation of license.**
