Dear Putnam County Electrical Journeyman:

This is a reminder that your Putnam County Electrical Journeyman license expires September 30, 2024.

We will no longer be mailing renewal packets.

REMEMBER: You need to have completed **two** Continuing Education Classes (CEU) prior to renewal. If you renewed for a 2022-2024 license, you would have taken a class in 2022. This would cover you for the 2022-2023 period of your current journeyman license. Therefore, you will need to take another CEU for the 2023-2024 period of your current journeyman license, prior to renewing.

This is a two (2) -year registration and the fee for the 2-year registration is \$100. YOU MUST RENEW OR SHELVE YOUR LICENSE (See below).

Please submit your renewal application promptly.

Your renewal must include the following:
☐ Renewal Application Form – completely filled out
☐ Child Support Obligations Form – completely filled out
☐ Copy of driver's license – Ensure that address on driver's license matches address on application. If not, please
provide proof of home address with utility bill, cable bill, etc.
□ Copy of your Continuing Education Certificate(s) (CEU)
☐ Check or Money Order (no cash accepted) in the amount of \$100.00 made payable to: Commissioner of Finance.
Credit card payments accepted in office only.

Incomplete applications will be returned unprocessed and may be subject to a late fee.

There is a late fee of \$50 for renewal applications received between October 1, 2024 to December 31, 2024.

Failure to renew or shelve your license by December 31, 2024, may result in the revocation of renewal privileges. After that date, you may have to reapply for the journeyman license, meet all the necessary qualifications and pass the journeyman exam.

According to Section 145-10 (H) in the Putnam County Law:

Revocation of renewal privileges. Failure to renew a license issued under the provisions of this chapter within ninety (90) days after expiration thereof may result in the complete revocation of all *renewal privileges* hereunder. Any person desiring a license after such revocation of privileges may be required to reapply for licensure in accordance with the provisions of this chapter, including the payment of all applicable fees and successful reexamination.
