REGULAR MEETING OF THE PUTNAM COUNTY LEGISLATURE HELD IN THE HISTORIC COURTHOUSE CARMEL, NEW YORK 10512

7:00 P.M.

The meeting was called to order at 7:01 P.M. by Chairman Jonke who requested Legislator Gouldman lead in the Pledge of Allegiance and Legislator Nacerino lead in the Legislative Prayer. Upon roll call, Legislators Montgomery, Gouldman, Addonizio, Nacerino, Ellner, Castellano, Sayegh, Crowley and Chairman Jonke were present. Also present was Legislative Counsel Firriolo.

PROCLAMATIONS

Chairman Jonke recognized Legislator Crowley who presented the "Domestic Violence Awareness" proclamation to Executive Director of the Women's Resource Center Piaget Solpiaget and Probation Director John Osterhout.

DOMESTIC VIOLENCE AWARENESS MONTH

WHEREAS, Domestic Violence is an epidemic affecting individuals in every community including Putnam County, regardless of age, economic status, sexual orientation, gender, race, religion, or nationality; and

WHEREAS, 1 in 3 women and 1 in 5 men are victims of some form of physical violence by an intimate partner; and

WHEREAS, in 2023 the Putnam Northern Westchester Women's Resource Center (WRC) answered 1,095 Hotline calls from victims; and

WHEREAS, WRC staff accompanied 89 victims to the Putnam County Sherriff, Court, District Attorney, Probation; and

WHEREAS, since it's opening in 2022 the Special Victim Unit, a joint project of the Women's Resource Center and the Putnam County Sheriff's Department has so far provided safe space for more than 50 adult victims to meet with law enforcement and victim advocates following a domestic violence and/or sexual assault incident; and

WHEREAS, the Women's Resource Center, the Putnam County Department of Probation, Sheriff's Department, District Attorney, Child Advocacy Center, and the Department of Social Services work tirelessly together to end domestic violence; now therefore be it

RESOLVED, that Putnam County Executive Kevin Byrne and the Putnam County Legislature do hereby proclaim October 2024 as "Domestic Violence Awareness Month" in Putnam County.

Chairman Jonke recognized Legislator Ellner who presented the "National Fire Prevention" proclamation to Commissioner of Emergency Services Robert Lipton.

NATIONAL FIRE PREVENTION WEEK - OCTOBER 6 - 12, 2024

WHEREAS, National Fire Prevention Week will be October 6-12, 2024, during which attention will be focused on promoting fire safety and prevention. In 2022, there were 1,504,500 reported fires in the United States, 3,790 deaths caused by fires, and 13,250 injuries. Those fires resulted in an estimated \$18.1 billion dollars in property damage; and

WHEREAS, The National Fire Protection Association (NFPA) has announced this year's Fire Prevention Week campaign: "Smoke alarms: Make them work for you! TM" strives to educate everyone about the importance of having working smoke alarms in the home; and

WHEREAS, Install smoke alarms in every bedroom, outside each separate sleeping area (like a hallway), and on each level (including the basement) of the home; and

WHEREAS, Test smoke alarms at least once a month by pushing the test button; and

WHEREAS, Replace all smoke alarms when they are 10 years old or stop responding when tested; and

WHEREAS, For the best protection, interconnect all smoke alarms. When one sounds, they all sound. It is important to have interconnected smoke alarms if you sleep with the bedroom doors closed; and

WHEREAS, Make sure smoke alarms meet the needs of all family members, including those with sensory or physical disabilities; and

WHEREAS, Putnam County is served by dedicated Volunteer Fire Departments whose service we greatly value and appreciate. In 2022 across this Nation there were 94 firefighter deaths and 65,650 firefighter injuries. Smoke alarms save lives, install smoke alarms in your house and test them monthly; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby proclaim the week of October 6-12, 2024 as National Fire Prevention Week in the County of Putnam and remind the citizens to make sure to install and test smoke alarms in your home.

Chairman Jonke recognized Legislator Addonizio who presented the "National Substance Abuse Prevention" proclamation to Dual Recovery Coordinator of DSS Lauren Johnson, Executive Director of the Prevention Council of Putnam Kristin McConnell and CoveCare Prevention Supervisor Melissa Lachapelle.

NATIONAL SUBSTANCE ABUSE PREVENTION MONTH

WHEREAS, Putnam County youth are negatively impacted by substance use with outcomes spanning from diminished academic achievement to socioemotional and safety concerns. The consequences are profound and can lead to a diagnosable Substance Use Disorder. Yet, there are evidence-based ways for our community to reduce risks and prevent negative outcomes. This month, we pay tribute to all those working to prevent substance use in our communities, and we rededicate ourselves to building a safer community, utilizing data-driven, and person-centered prevention efforts for all Putnam County residents; and

WHEREAS, by increasing awareness and reducing stigma associated with substance use, we can prevent use before it starts and increase access to supports and services; and

WHEREAS, all residents can play a role in preventing substance use. Parents and caregivers can help by talking to their kids about the dangers of substances, both legal and illegal and can also be aware of the example they set with their own behaviors.

Community coalitions comprised of school personnel, law enforcement, behavioral health professionals, faith leaders, local government and community members gather together to address substance use in their communities; and

WHEREAS, we observe National Substance Use Prevention Month, let us help to address the stigma faced by those with Substance Use Disorder by mindfully labeling our recognition as "Substance Use Prevention Month" paying particular attention to preventing and delaying onset of any substance use, and reducing negative outcomes; now therefore be it

RESOLVED, That the Putnam County Executive and Putnam County Legislature do hereby proclaim October 2024 as Substance Use Prevention Month. The Putnam County Department of Mental Health, the Prevention Council of Putnam, CoveCare Center and all substance use support services in Putnam County encourage all residents to increase their awareness of Substance Use Disorder, the dangers of substance use, the success of evidence-based prevention programs and to actively support and encourage referrals for services.

Legislator Nacerino explained that the Community Engagement & Police Advisory Committee Board has submitted correspondence indicating that they would like to continue with this Advisory Board. She explained that the Board has served as a bridge of communication between the police departments and the residents of Putnam County. They are committed to transparency, accountability and community involvement.

Legislator Addonizio thanked the Advisory Board for their commitment to Putnam County.

Chairman Jonke recognized the members of the Advisory Boad for their dedicated service and hard work.

Item #6k – Approval – Local Law to Amend the Charter of Putnam County by Amending Article 8, Section 8.01 Entitled "Department of Law – County Attorney" was next. On behalf of the members of the Rules, Enactments & Intergovernmental Relations Committee, Legislators Ellner and Nacerino, Legislator Addonizio moved the following:

Legislator Crowley read a statement which voiced her concerns against this proposed local law amendment. She believed it was personal and political. She believed the proposal curtailed the County Executive's authority, in which she or he can remove a public officer. She stated that the proposal fundamentally changes checks and balances and undermines the Executive's ability to administer departments. It is also not written to include a mandatory referendum.

Legislator Montgomery stated that there were two (2) recusals from a Legislator regarding this matter. She wondered if we would have that recusal again.

Chairman Jonke questioned on what grounds.

Legislator Montgomery stated that this is the same issue where the Legislator previously recused themselves. She stated that nothing has changed.

Chairman Jonke stated that a lot has been changed.

Legislator Montgomery voiced her concerns with the proposal and believed that power was being taken away from the County Executive and he would not be able to retain an attorney.

Chairman Jonke stated that he would allow that Legislator to answer the recusal question when the time comes. He explained that nothing changes for the County Executive; we are not changing any of his authority. He stated that the County Attorney works for the Legislature. He stated that the Legislature is not a county department; we are a branch of government. He stated that the Legislature has the authority to confirm the County Executive's choice of County Attorney, and he believed that we should also have the right to remove that person too. He stated that this proposal gives the ability of this Legislature to be able to remove our attorney. He stated that this was personal and

political when the County Attorney filed an ethics complaint against a member of this Legislature after he was, in his words "summoned" to a Rules Committee meeting. He explained that the previous County Attorney never felt they were being summoned when they were invited to a Legislative meeting to address questions or provide updates on legal topics in the County. He stated that the retaliation came from the County Attorney.

Legislator Nacerino stated that she is in favor of this proposal. She believed that we were conflating the issue. She believed the comments being made were based on speculation and conjecture. She stated that the Legislature is an equal branch of government and should have the right to choose our own attorney. She stated that from the beginning this was about giving the Legislature the voice that we deserve. She stated that it has no effect on the present County Attorney, and this was done to ensure there were no misinterpretations. She supported this legislation.

Legislator Gouldman believed that this was a bad law. He stated that it would change the balance of power. He stated that the current system has checks and balances between the branches of government. He stated that we must depend on the authority of each branch of government. He believed that by passing this law, we were chipping away the authority of the Executive branch. He questioned what powers we were going to go after next. He did not support this legislation.

Chairman Jonke clarified that this was not chipping away any authority from the County Executive.

Legislator Montgomery stated that based on what Chairman Jonke, she believed this proposal was retaliation. She stated that this proposal was impeding the County Executive's ability to choose his own representation and putting him in a position to appoint a new individual to the post in the hope that the Legislature agrees with his choice. She stated that the County Attorney would then feel pressured to continuously please the members of the Legislature, thereby placing the position of County Attorney squarely within the Legislature's control and jurisdiction.

Legislator Montgomery made a motion to remove this proposal from the agenda; seconded by Legislators Gouldman and Crowley.

By Roll Call Vote: Three Ayes – Legislators Crowley, Gouldman & Montgomery. Six Nays – Legislators Addonizio, Castellano, Ellner, Nacerino, Sayegh & Chairman Jonke. Motion Fails.

Legislator Nacerino stated that again, this is based on speculation and opinion. She stated that this was brought to the forefront because it raised the awareness of the situation, it was not because anyone was retaliating. If it was retaliatory, this County Attorney would not be exempt. She stated that this law will not take effect until January 1, 2027.

Legislator Ellner stated that there is a provision in the local law that is very good that we have been overlooking. He stated that it says, "the County Attorney shall not engage in any private practice nor be employed by any private law firm or other governmental entity in his or her field of expertise of employment." He believed it was important that when we hire a County Attorney that they work solely for Putnam County.

Legislator Castellano stated that to continue along that line, the current County Attorney is excluded from the wording. He stated that we have taken that into consideration and there is nothing retaliatory here.

Legislator Crowley stated that we were not only talking about the County Attorney, but also his office and their ability to help the County.

Chairman Jonke called for a Roll Call Vote on the proposed local law.

RESOLUTION #215

APPROVAL - LOCAL LAW TO AMEND THE CHARTER OF PUTNAM COUNTY BY AMENDING ARTICLE 8, SECTION 8.01 ENTITLED "DEPARTMENT OF LAW - COUNTY ATTORNEY"

Be it enacted by the Legislature of the County of Putnam as follows:

Section 1.

Section 8.01 of the Charter of the County of Putnam is hereby amended to read as follows:

§ 8.01 – Department of Law – County Attorney

There shall be a Department of Law under the direction of a County Attorney who shall be appointed by the County Executive, subject to confirmation by the County Legislature. At the time of his or her appointment, and throughout his or her term of office, the County Attorney shall be and remain duly licensed and entitled to practice law in the State of New York. He or she shall be appointed on the basis of his or her legal experience and other qualifications for the responsibilities of his or her office. The County Attorney may be removed by the County Executive, subject to a two-thirds vote of concurrence by the County Legislature. The County Attorney may also be removed by the County Legislature by a two-thirds vote of the Legislature, however, this provision shall not be applicable to the County Attorney serving at the time this law takes effect. The County Attorney shall not engage in any private practice nor be employed by any private law firm or other governmental entity in his or her field of expertise of employment. This restriction on employment by the County Attorney shall not be applicable to the County Attorney serving at the time this law takes effect.

Section 2.

This Local Law shall take effect on January 1, 2027 and is subject to permissive referendum.

BY ROLL CALL VOTE: SIX AYES. THREE NAYS – LEGISLATORS CROWLEY, GOULDMAN & MONTGOMERY. MOTION CARRIES.

Item #6L – Approval – Appointment of Outside Counsel for the Legislature was next. On behalf of the members of the Rules, Enactments & Intergovernmental Relations Committee, Legislators Ellner and Nacerino, Legislator Addonizio moved the following:

Legislator Montgomery stated that this was related to the previous local law. She believed that this was serving the Legislature instead of serving the people of Putnam County.

Legislator Crowley stated that in the great words of Nancy Pelosi, where we must pass a bill to find out what is in it, she explained that we have not addressed what the matters are or what we need outside counsel for. She did not believe that FOIL was a conflict of interest. She stated that if certain members of the Legislative body feel that we need outside counsel, then write a memo and do your own bidding.

Legislator Nacerino stated that we just approved \$150,000 for outside legal services for the Law Department that cannot handle their own workload that is coming out of contingency. She stated that the Legislature had an executive session last month where an outside attorney came because the County Attorney was not present. She stated that this was unprecedented in her 12 years when the former County Attorney was present at every executive session for a settlement. She stated that we do not just do "a memo" to obtain counsel. She stated that this whole toboggle was not created by anyone on this Legislature. She stated that the Law Department then assigned the Legislature an outside counsel. She stated that we should have the right to choose our own attorney. She stated that as an equal branch of government, the County Attorney serves the Legislature if there is a conflict between the County Executive and the County Legislature. She stated that it is the County Attorney's obligation to serve the County Legislature first and foremost. She stated that she supports this legislation.

Chairman Jonke stated that this is unrelated to the previous local law just approved. He stated that if more details are wanted, he stated that we have the County Attorney's brother FOILing records from our office. He stated that some of those records may be deemed confidential. He stated that we do not have an attorney to advise us other than the attorney that the County Attorney has recommended. He stated that there may be or may not be an inherent conflict in that. He stated that, as Chairman of the Legislature, he would feel more comfortable being able to choose our own attorney.

Legislator Gouldman believed that the language should be specific. He stated that we have been assigned outside counsel.

Legislator Castellano stated that we just approved \$150,000 which the County Attorney asked for tonight for outside counsel invoices. He stated that the County Attorney appointed outside counsel for us, which we are in a disagreement with right now. He believed it was in our best interest that we choose our own counsel in this circumstance.

Legislator Nacerino called the question.

By Roll Call Vote: Six Ayes – Legislators Addonizio, Castellano, Ellner, Nacerino, Sayegh and Chairman Jonke. Three Nays – Legislators Crowley, Gouldman and Montgomery. Motion Fails.

Chairman Jonke called for a Roll Call Vote on the resolution.

RESOLUTION #216

APPROVAL/ APPOINTMENT OF OUTSIDE COUNSEL FOR THE LEGISLATURE

WHEREAS, by memorandum dated September 11, 2024, the Chair of the Legislature informed the County Attorney that, due to actual or potential conflicts involving the Law Department and Legislative Counsel, the Legislature finds itself in the position of being without counsel on several different matters; and

WHEREAS, in said memorandum, the Chair of the Legislature requested that, pursuant to Putnam County Code Section 140-3.5 ("Contracting for legal services"), the County Attorney appoint Keane & Beane, P.C., Attorneys at Law, as counsel to the Legislature; and

WHEREAS, Putnam County Code Section 140-3.5 authorizes the County Legislature to approve its own procurement for a contract for the services of legal counsel, which shall be approved by the Chairperson of the Legislature and the County Attorney; and

WHEREAS, pursuant to Putnam County Charter Section 8.02(f), the County Attorney shall have all the powers and perform all the duties conferred or imposed by law on a County Attorney, and perform such other and related nonconflicting duties required by the County Executive or the County Legislature; and

WHEREAS, it is a conflicting duty for the County Attorney to approve or deny approval of the Legislature's choice of counsel to deal with matters where the County Attorney has a conflict; and

WHEREAS, pursuant to Putnam County Charter 2.04(q), the County Legislature shall have the power to appoint, as deemed necessary and proper, by resolution duly adopted, outside counsel on a per case basis; now therefore be it

RESOLVED, that, pursuant to Putnam County Code Section 140-3.5, the Putnam County Legislature approves the procurement for a contract for the services of legal counsel with Keane & Beane, P.C., Attorneys at Law, as counsel to the Legislature, as previously approved by the Chair of the Legislature; and be it further

RESOLVED, that in the event that there is any impediment to the procurement of such a contract pursuant to Putnam County Code Section 140-3.5, the Legislature invokes its authority pursuant to Putnam County Charter 2.04(q) to directly appoint outside counsel for the purpose of dealing with matters where there is a conflict involving the County Attorney or the Department of Law; and be it further

RESOLVED, that in the event the firm of Keane & Beane is unable or unwilling to accept the appointment for any reason, or to continue as counsel to the Legislature after being engaged, the Chair of the Legislature shall approve and be authorized to appoint alternate counsel for the Legislature.

The meeting was called to order at 6:00 P.M. by Chairman Jonke who requested that Legislator Sayegh lead in the Pledge of Allegiance and the Legislative Prayer. Upon roll call, Legislators Montgomery, Gouldman, Addonizio, Nacerino, Ellner, Castellano, Sayegh and Chairman Jonke were present. Legislator Crowley was absent. Also present was Legislative Counsel Firriolo.

Item #4 – Approval – Local Law Strengthening the Term Limit Provisions for the Office of Putnam County Legislator was next.

Chairman Jonke stated that this was something he brought forward to strengthen term limits here in Putnam County for the Legislature. He stated that right now it only takes six (6) members of the Legislature to overturn the term limits. He believed term limits were important as it limits a person's ability to make careers out of these jobs. He believed that was part of the problem with members in the United States Congress who are there for 30 or 40 years. He believed that the longer they stayed, there was less democracy.

Legislator Gouldman explained that many individuals were frustrated with the current American political system. He stated that this has generated an interest in setting term limits for lawmakers throughout the Country. He stated that this Legislature had the foresight in 2013 when term limits were set for the County Executive and County Legislature. He explained that the nine (9) Legislators have staggering terms. Each year there are three (3) Legislators that are up for re-election, and each member is only allowed 12 years of service. He believed it made sense to refresh the people who serve in this position. He stated that this proposed law will strengthen term limits as mentioned by Chairman Jonke. He stated that he would support this legislation.

Legislator Montgomery did not know how a law could be passed requiring a unanimous vote without a unanimous vote. She explained that she was in favor of term limits, however, she believed the term limits we currently have were working. She did not believe this was vetted through the Law Department and she questioned the legality of it. She would rather see it go to public referendum. She believed it hamstringed future Legislators because we do not know if the State will approve legislation regarding even years for terms.

Legislator Nacerino stated that she will be supporting this. She firmly believed that term limits were good and she did not want people to become career politicians in Putnam County; we see too much of that in Albany. She believed there has been ample time to vet this, and we had Legislative Counsel weigh in on this.

Legislator Sayegh stated that she also supports term limits and supports this change. She stated that currently six (6) Legislators could do away with term limits. She stated that this should not be taken lightly. She believed if all nine (9) Legislators vote in tandem it gives an opportunity to work together to have a good reason for a change.

Legislator Montgomery clarified that she supports term limits. She believed that the system we have now works. She stated that she would be voting against it because she believed it was not vetted properly.

RESOLUTION #309

A LOCAL LAW STRENGTHENING THE TERM LIMIT PROVISIONS FOR THE OFFICE OF PUTNAM COUNTY LEGISLATOR

Section 1. The Legislature of the County of Putnam, New York hereby makes the following findings and determinations:

- (a) that Local Law No. 8 of 2013 ("Local Law No. 8"), enacted by the County Legislature on July 2, 2013, sets forth a term limits regime for the office of County Legislator which currently may be amended merely by the favorable vote of two-thirds of all the members of the County Legislature, subject to permissive referendum; and
- (b) that a system of governmental term limits engenders transparency in government, promotes the accountability of public officials, and increases public trust, as well as provides for the opportunity for new voices and new ideas to be heard; and
- (c) that in order to engender transparency in government, promote accountability, and to increase public trust, this County Legislature is desirous of requiring a unanimous vote of the County Legislature in order to amend, modify or repeal term limits for the office of County Legislator; and
- (d) that this County Legislature finds and determines that this Local Law changes its voting power and curtails its power relative to the amending, modifying or repealing of the term limits procedures of the County Legislature by increasing the number of affirmative votes necessary of the County Legislature in order to amend, modify or repeal the term limits procedures of the office of County Legislator, and
- (e) that this County Legislature hereby finds and determines that this Local Law embraces only one subject: that of the term of the office of County Legislator,

NOW THEREFORE, BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF PUTNAM AS FOLLOWS:

Section 2. Article 2, Section 2.02 of the Putnam County Charter is hereby amended to read as follows:

- A. The County Legislators shall be elected for terms of three (3) years at the general elections hereinafter provided and every three (3) years thereafter as follows:
- (1) At the general election held in November of 2026, County Legislators from Legislative Districts Two, Three and Eight shall be elected for said term of three years.

- (2) At the general election held in November of 2027, County Legislators from Legislative Districts One, Four and Seven shall be elected for said term of three years.
- (3) At the general election held in November of 2025, County Legislators from Legislative Districts Five, Six and Nine shall be elected for said term of three years.
- B. With the exception of a partial term, the County Legislators shall serve a maximum of four (4) terms.
- C. With the exception of a partial term, in no instance may a Legislator serve more than four terms or 12 years, whichever is less.
- D. Except in the instance where a general or special state law would otherwise necessitate, amending, modifying or repealing the term limit provisions as set forth in this Section 2.02 may only be accomplished by the enactment of a local law adopted by the County Legislature by a unanimous vote of the whole of its number, subject to referendum on petition as provided in the Municipal Home Rule Law.

Section 3. Article 3, Section 3.04-B(d) of the Putnam County Charter is hereby amended by adding the following paragraphs:

(d) Reconsideration.

Except as otherwise set forth in this Section 3.04-B, a vetoed enactment shall be resubmitted to the County Legislature together with the veto message at its next regular or special meeting, and such message shall be entered into its Book of Proceedings. Within thirty (30) days after such receipt and entry, the County Legislature may reconsider the vetoed enactment and pass the same over the County Executive's objections by a favorable vote of two-thirds (2/3) of the whole of its number on a roll-call vote. Only one such reconsideration vote shall be taken on any single vetoed enactment.

Other than the veto of an enactment necessitated by the passage of a general or special state law, a vetoed enactment amending, modifying or repealing the term limit provisions as set forth in Section 2.02 of the County Charter shall be resubmitted to the County Legislature together with the veto message at its next regular or special meeting, and such message shall be entered into its Book of Proceedings. Within thirty (30) days after such receipt and entry, the County Legislature may reconsider the vetoed enactment and pass the same over the County Executive's objections by a unanimous vote of the whole of its number on a roll-call vote. Only one such reconsideration vote shall be taken on any single vetoed enactment.

Section 4. Article 15, Section 15.01 of the Putnam County Charter is hereby amended by adding the following paragraphs:

Except as otherwise set forth in this Section 15.01, a Charter amendment may be proposed by a member of the County Legislature, the County Executive or the Legislative bodies of any of the towns or villages of the County. The proposal must then be enacted by a local law passed by a two-thirds (2/3) vote of the County Legislature subject to referendum on petition as provided in the Municipal Home Rule Law. Any proposed amendment which would have the effect of transferring a function or duty of the County or of a town, village, district or other unit of local government of the County shall not become operative unless

it is approved by mandatory referendum. Any amendment which would create or abolish an elected office; change the power of an elected County officer during his or her term of office; abolish, curtail or transfer to another County officer or agency any power of an elected County officer, or change the method of election of the County Legislature, but not including decennial reapportionment, shall be subject to a permissive referendum.

Except in the instance where a general or special state law would necessitate such, a Charter amendment amending, modifying or repealing the term limit provisions as set forth in Section 2.02 of the County Charter may only be enacted by a local law passed by a unanimous vote of the County Legislature, subject to referendum on petition as provided in the Municipal Home Rule Law.

Section 5. If any provision of this Local Law is held to be illegal or invalid for any reason, such illegality or invalidity shall not affect the remaining provisions hereof, but such provision shall be fully severable and this Local Law shall be construed and enforced as if such illegal or invalid provision had never been included.

Section 6. Pursuant to Section 34(5) of the Municipal Home Rule Law, this Local Law shall take effect sixty (60) days after its final enactment and is subject to permissive referendum.

BY ROLL CALL VOTE: SEVEN AYES. ONE NAY - LEGISLATOR MONTGOMERY. LEGISLATOR CROWLEY WAS ABSENT. MOTION CARRIES.

Item #5 – Approval – Local Law Strengthening the Term Limit Provisions for the Office of Putnam County Executive was next.

Chairman Jonke moved the following. He stated that this is the same rationale for the term limits of County Executive. He explained that all we are doing is strengthening the term limits requiring nine (9) votes instead of six (6) votes to make a change.

Legislator Gouldman stated that for the same reasons he previously mentioned, he would be supporting this.

RESOLUTION #310

A LOCAL LAW STRENGTHENING THE TERM LIMIT PROVISIONS FOR THE OFFICE OF PUTNAM COUNTY EXECUTIVE

Section 1. The Legislature of the County of Putnam, New York hereby makes the following findings and determinations:

- (a) that Local Law No. 8 of 2011 ("Local Law No. 8"), enacted by the County Legislature on January 4, 2011, sets forth a term limits regime for the office of County Executive which currently may be amended merely by the favorable vote of two-thirds of all the members of the County Legislature, subject to permissive referendum; and
- (b) that a system of governmental term limits engenders transparency in government, promotes the accountability of public officials, and increases public trust, as well as provides for the opportunity for new voices and new ideas to be heard; and

- (c) that in order to engender transparency in government, promote accountability, and to increase public trust, this County Legislature is desirous of requiring a unanimous vote of the County Legislature in order to amend, modify or repeal term limits for the office of County Executive; and
- (d) that this County Legislature finds and determines that this Local Law changes its voting power and curtails its power relative to the amending, modifying or repealing of the term limits procedures of the County Executive by increasing the number of affirmative votes necessary of the County Legislature in order to amend, modify or repeal the term limits procedures of the office of County Executive, and
- (e) that this County Legislature hereby finds and determines that this Local Law embraces only one subject: that of the term of the office of County Executive,

NOW THEREFORE, BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF PUTNAM AS FOLLOWS:

Section 2. Article 3, Section 3.01 of the Putnam County Charter is hereby amended by adding a second paragraph to such Section:

Except in the instance where a general or special state law would otherwise necessitate, amending, modifying or repealing the term limit provisions as set forth in this Section 3.01 may only be accomplished by the enactment of a local law adopted by the County Legislature by a unanimous vote of the whole of its number, subject to referendum on petition as provided in the Municipal Home Rule Law.

Section 3. Article 3, Section 3.04-B(d) of the Putnam County Charter is hereby amended by adding the following paragraphs:

(d) Reconsideration.

Except as otherwise set forth in this Section 3.04-B, a vetoed enactment shall be resubmitted to the County Legislature together with the veto message at its next regular or special meeting, and such message shall be entered into its Book of Proceedings. Within thirty (30) days after such receipt and entry, the County Legislature may reconsider the vetoed enactment and pass the same over the County Executive's objections by a favorable vote of two-thirds (2/3) of the whole of its number on a roll-call vote. Only one such reconsideration vote shall be taken on any single vetoed enactment.

Other than the veto of an enactment necessitated by the passage of a general or special state law, a vetoed enactment amending, modifying or repealing the term limit provisions as set forth in Section 3.01 of the County Charter shall be resubmitted to the County Legislature together with the veto message at its next regular or special meeting, and such message shall be entered into its Book of Proceedings. Within thirty (30) days after such receipt and entry, the County Legislature may reconsider the vetoed enactment and pass the same over the County Executive's objections by a unanimous vote of the whole of its number on a roll-call vote. Only one such reconsideration vote shall be taken on any single vetoed enactment.

Section 4. Article 15, Section 15.01 of the Putnam County Charter is hereby amended by adding the following paragraphs:

Except as otherwise set forth in this Section 15.01, a Charter amendment may be proposed by a member of the County Legislature, the County Executive or the Legislative bodies of any of the towns or villages of the County. The proposal must then be enacted by a local law passed by a two-thirds (2/3) vote of the County Legislature subject to referendum on petition as provided in the Municipal Home Rule Law. Any proposed amendment which would have the effect of transferring a function or duty of the County or of a town, village, district or other unit of local government of the County shall not become operative unless it is approved by mandatory referendum. Any amendment which would create or abolish an elected office; change the power of an elected County officer during his or her term of office; abolish, curtail or transfer to another County officer or agency any power of an elected County officer, or change the method of election of the County Legislature, but not including decennial reapportionment, shall be subject to a permissive referendum.

Except in the instance where a general or special state law would necessitate such, a Charter amendment amending, modifying or repealing the term limit provisions as set forth in Section 3.01 of the County Charter may only be enacted by a local law passed by a unanimous vote of the County Legislature, subject to referendum on petition as provided in the Municipal Home Rule Law.

Section 5. If any provision of this Local Law is held to be illegal or invalid for any reason, such illegality or invalidity shall not affect the remaining provisions hereof, but such provision shall be fully severable and this Local Law shall be construed and enforced as if such illegal or invalid provision had never been included.

Section 6. Pursuant to Section 34(5) of the Municipal Home Rule Law, this Local Law shall take effect sixty (60) days after its final enactment and is subject to permissive referendum.

BY ROLL CALL VOTE: SEVEN AYES. ONE NAY - LEGISLATOR MONTGOMERY. LEGISLATOR CROWLEY WAS ABSENT. MOTION CARRIES.

Item #6 - Other Business

Item #6a – Reconsideration - 2025 Budget Resolution #266 of 2024 – Law Department – Remove Salary Adjustment for Senior Deputy County Attorney - Vetoed by County Executive was next.

Legislator Gouldman stated that this is not illegal, but it should be. The Legislature should be giving proper notice for items like this. He believed it should be on the agenda to give enough time so residents and Legislators can decide how they want to vote. He stated that we are asked to override a veto by the County Executive with four (4) hours and seven (7) minutes notice through an email we received at 1:53 P.M. He stated that we have given everyone a raise in the County, but we are singling out one (1) individual by removing a \$5,000 salary adjustment for the Senior Deputy County Attorney. He questioned why we were doing this. He believed it was wrong and stated that he would not support this.

Legislator Montgomery questioned if the Legislative Manual referred to procedure for holding a Special Meeting and having something added to the agenda.

Chairman Jonke explained that because it is a budget related veto there is a strict timeline. He stated that because we were meeting this evening, he believed it was wise to include it under other business.

Legislative Counsel Firriolo explained that the time frame we are working under is that the Charter requires the Chairman of the Legislature to convene a meeting of the Legislature on or before November 15th to consider a veto. He stated that given the time frame, it falls outside the calling of a Special Full meeting because there is no opportunity for the full notice period that there would be for a normal Special. The Charter said it needs to be done before November 15th. He stated that once the veto came to the Legislature on November 8th and there was a holiday on Monday the 11th, that only leaves Tuesday through Friday hold a meeting. He stated that you would not be able to notice the meeting as you would a Special meeting in any event.

Legislator Nacerino stated for the record, the veto did not come to the Legislature until close to 5:00 P.M. There was no ample time, other than the time we've had to really read and digest it. She stated that this is a stipend/merit raise. It is not the denial of a COLA raise or that we are "singling" someone out. She stated that it was her understanding that this is a part-time employee and has not been with the County that long. She stated that we felt it was prudent not to give these merit raises arbitrarily. She stated that it was in her opinion that the COLA increase should be implemented but not a stipend for a part-time employee who has been here less than one (1) year.

Legislator Gouldman explained that the person in this position previously worked for the County in another department.

Legislator Montgomery stated that she understood the time frame needed to consider this veto by November 15th. She believed that another meeting could be scheduled and that the public needed to have this information. She stated that it clearly states in our Legislative Manual, Rule 27 – "Only business specified in the notice thereof may be transacted at a special meeting." She stated that this was not noticed properly. She believed this position was backfilling a vacant position, and in essence saving the County money. She questioned if there was a vacant position in the Law Department that we did not fill. She stated that this is the only raise that we are denying throughout the County. She stated that we gave stipends and raises to other employees. She proceeded to read the County Executive's veto message. She stated that based on this veto message, she believed at least one (1) of the members of this Legislature should not be voting on this at all. She believed that it appears that we are singling out an employee and a department. She believed it was retaliation against the County Attorney.

Chairman Jonke stated to Legislator Gouldman's point, this is not an illegal meeting. He believed that the Charter overrides the Legislative Manual when it pertains to this Special meeting.

Legislative Counsel Firriolo stated that it does. He stated that Rule 27 cannot apply because Rule 27 requires that a Special meeting be called by the Chair and four (4) other Legislators, or written request by a majority. He stated that the Charter states that it has to be called. He stated that Rule 27 does not apply to budget override meetings.

Chairman Jonke stated to Legislator Gouldman that this less than full-time employee who receives health benefits, is still getting a cost-of-living adjustment. She is still

receiving that raise. We are not cutting her compensation. He stated that we all received an email early today from someone he respects very much. He stated that he was led to believe that this employee was taking a pay cut, which is not true. He stated that the employee started working in the Law Department on January 1st of this year. He stated that with less than one (1) year of service they are already putting in for a merit raise. He stated that during the budget process, there was never anyone here from the Law Department to go to bat for this employee and support or explain the increase. He stated that when we asked the Deputy County Executive why this was being done, the answer we received was, "I don't know." He stated that on May 16th of 2024, this attorney sat in this room and told this Legislature that a lawsuit that was filed in December of 2023 was authorized by the County Executive. He stated that this lawsuit was filed in December of 2023 and never showed up on the litigation report for six (6) months. He stated that it was hidden for six (6) months, and we received a determination in early May of 2024 that we had succeeded in this lawsuit. He stated that this attorney stated that we did not have authority. He stated that it is very clear in the Charter that the Legislature is the only authority that can approve a lawsuit. He stated that the County Attorney's office sued a resident of this County without the Legislature's authorization. He stated that the attorney stated that she received the authorization from the County Executive, which turned out to be untrue. He stated that he called the Deputy County Executive the following day and questioned if he asked for a copy of the request and the approval, what would he receive. The Deputy County Executive said that the Law Department never asked. He stated that in the County Executive's veto message it states that the attorney's compensation is being cut. He stated that her compensation is not getting cut. She is receiving the cost-of-living adjustment just like everyone else in the County. She is just not receiving a merit raise.

Legislator Nacerino explained that the Legislature was lied to during that meeting. She stated that she found it ironic that the County Executive stipulated that we are singling out a salary adjustment. Legislator Nacerino stated that she did not even know this employee in any shape or form to have a personal opinion. She stated that there was no retaliation going on. She found it ironic that the County Executive stated that we were "singling out" when he singled out the Sheriff, Coroners and County Clerk again in this budget process with no explanation other than we should wait until after contract negotiations. She stated that the County Clerk or Coroners have no interaction pertaining to contract negotiations.

Legislator Ellner stated that two (2) times in the veto message the County Executive, who he believed created this type of position, indicated that this employee is part-time. He stated that a part-time employee is not entitled to health benefits. He stated that at a previous Committee meeting when the Legislature questioned the position, it was stated that the employee was designated as less than full-time which is why they receive health benefits. He questioned why the County Executive is stating that the position is part-time.

Personnel Officer Paul Eldridge stated that he went through the explanation when the question came up at the Committee meeting. He stated that the only definition of part-time is half-time or less. He stated that this employee works more than that. He stated that the reference to part-time would be technically incorrect. He stated that the person works six (6) out of seven (7) hours. He explained that the employee works 30 hours per week; six (6) hours per day times five (5) days per week equals 30 hours. He stated that

there are certain benefits that accrue with that. He stated that the Affordable Care Act requires that we offer health insurance.

Legislator Montgomery explained that the County Clerk, County Coroner, and the Sheriff, as referenced by Legislator Nacerino, are all elected positions and that was the reason for holding back the COLA. She explained that Chairman Jonke stated that this employee has only been here one (1) year, and the salary is being adjusted. She believed that we did the same for the Sheriff's command staff in a very short time, bringing them up to a deserving salary even though they were all new employees.

Chairman Jonke stated that it was factually untrue.

Legislator Nacerino believed that we were going to agree to disagree and go around and around. She asked that we move to a roll call vote.

Chairman Jonke stated that he wanted to make sure that everyone had a chance to speak.

There being no further comment, Chairman Jonke called for a Roll Call Vote.

RESOLUTION #311

RECONSIDERATION - 2025 BUDGET RESOLUTION #266 OF 2024 – LAW DEPARTMENT – REMOVE SALARY ADJUSTMENT FOR SENIOR DEPUTY COUNTY ATTORNEY - VETOED BY COUNTY EXECUTIVE

RESOLVED, that the County Executive's veto of Budget Resolution #266 of 2024, removing the \$5,000 Salary Adjustment for the Senior Deputy County Attorney in the Law Department, after Legislative reconsideration, is hereby overridden.

BY ROLL CALL VOTE: SIX AYES. TWO NAYS – LEGISLATORS GOULDMAN & MONTGOMERY, LEGISLATOR CROWLEY WAS ABSENT. MOTION CARRIES.

There being no other business, at 6:28 P.M., Chairman Jonke made a motion to adjourn; seconded by Legislator Sayegh. All in favor.

I am requesting the following item be placed on the Agenda for the December 17^h, 2024 Protective Services Committee Meeting;

- a. Use of Federal Seized Forfeiture funds to purchase firearms related equipment known as pistol mounted optical devices. The amount we are requesting for this Project is \$150,000 dollars.
 - a. There is no Fiscal Impact on the PCSO Budget, and the use of these funds shall save the taxpayers money.
- b. These are some of the rationalizations for the transition from iron sights to an optic based sight.
 - a. By utilizing an optic on a pistol, the Deputy is able to keep both eyes open and focused on the intended target or threat while processing all necessary information during the engagement,
 - The single focal point approach allows the Deputy's eyes to take in the entire field of view both through the optic window and around it without any restrictions, AND
- c. Promotes faster learning. By putting the sight and the target in the same optical plane, an optic simplifies the task of aiming the weapon and decreases the amount of time and effort required to obtain proficiency, compared to iron sights.
- d. Promotes better performance. Optics can decrease the time required to get good views on target by making the sighting task less difficult. This is especially true as the apparent size of the target decreases due to distance or exposure. It's also valid when a Deputy has to fight from an awkward position due to injury, or to make effective use of cover. Optics

also encourage better performance against moving or low light targets, which can be more challenging to hit using iron sights, especially if they lack illumination.

- e. Decrease the training maintenance burden. Because they encourage better results with less effort, optics can decrease the amount of time, ammunition and effort necessary to maintain the desired level of performance with the secondary weapon, once a Deputy has received initial training. This conserves precious resources, which can be used elsewhere in training.
- f. I have attached a memorandum to this request from the Putnam County Sheriff'[s Office Lead firearms Instructor outlining additional benefits for this request.





I am requesting the following item be placed on the Agenda for the December 17^h, 2024 Protective Services Committee Meeting;

- Use of Federal Seized Forfeiture funds to purchase firearms related equipment known as pistol mounted optical devices. The amount we are requesting for this Project is \$150,000 dollars.
 - a. There is no Fiscal Impact on the PCSO Budget, and the use of these funds shall save the taxpayers money.
- b. These are some of the rationalizations for the transition from iron sights to an optic based sight.
 - a. By utilizing an optic on a pistol, the Deputy is able to keep both eyes open and focused on the intended target or threat while processing all necessary information during the engagement,
 - b. The single focal point approach allows the Deputy's eyes to take in the entire field of view both through the optic window and around it without any restrictions, AND
- c. Promotes faster learning. By putting the sight and the target in the same optical plane, an optic simplifies the task of aiming the weapon and decreases the amount of time and effort required to obtain proficiency, compared to iron sights.
- d. **Promotes better performance.** Optics can decrease the time required to get good views on target by making the sighting task less difficult. This is especially true as the apparent size of the target decreases due to distance or exposure. It's also valid when a Deputy has to fight from an awkward position due to injury, or to make effective use of cover. Optics

- also encourage better performance against moving or low light targets, which can be more challenging to hit using iron sights, especially if they lack illumination.
- e. **Decrease the training maintenance burden.** Because they encourage better results with less effort, optics can decrease the amount of time, ammunition and effort necessary to maintain the desired level of performance with the secondary weapon, once a Deputy has received initial training. This conserves precious resources, which can be used elsewhere in training.
- f. I have attached a memorandum to this request from the Putnam County Sheriff'[s Office Lead firearms Instructor outlining additional benefits for this request.

PURCHASE REQUEST FOR PISTOL MOUNTED OPTICS

This writer, in his capacity as the Lead Firearms Instructor for the Putnam County Sheriff's Office (PCSO), is respectfully requesting funds for the purchase of and the transition to Pistol Mounted Optics and all necessary accessories for their mounting and usage on department issued weapons by the men and women of the PCSO.

Pistol Mounted Optics have gained popularity in all levels of firearms shooting (recreational, law enforcement, and military) over the last decade. While initially thought of as obscure and niche during experimental times in the 1990's and viewed as a flash in the pan by some long-term instructors in the 2010's, their impact on the pistol shooting world is undeniable. The ability to no longer focus on 3 focal planes with your eyes (threat, rear sight, and front sight of pistol), and to remain solely threat focused with your eyes is by far the greatest advantage for law enforcement. This advantage will greatly reduce liability for mistake of fact shootings where law enforcement must rapidly identify objects in a subject's hands yet are forced to be focused on the front sight of their pistol while engaged with a threat. The most basic argument can be made that human instinct dating from the earliest recorded history has always been threat focused once primitive weapons (spear, bows, slings etc.) were created (Cowan 2023). Iron sights significantly diminish the ability to remain threat focused while Pistol Mounted Optics use requires one to superimpose a dot on a threat with no loss of clarity in vision of the threat.

The second greatest advantage of Pistol Mounted Optics use is the increase in accuracy that can be attained. Removing the need to focus on three things at once (threat, front sight, rear sight) eliminates the potential inaccuracy caused by failing to have proper sight alignment. Removing the need for alignment and moving to a threat focus with a dot placed where you intend the projectile to go to, decreases the number of factors that can go wrong while aiming. Other fundamentals of shooting, mainly grip and draw/presentation, can then be honed to achieve quicker, more repeatable actions from the individual firing

the weapon. As an instructor for the PCSO since 2013, this writer has witnessed many members, both here and in basic recruit academies, struggle with the concept of aiming properly and having repeatable actions while firing. In the private sector, over the course of the last seven years, this writer has witnessed numerous entry level shooters make tremendous gains in their ability and confidence using Pistol Mounted Optics systems. Many in the private sector have pushed for the use of Pistol Mounted Optics systems as they are easier to teach the concepts of aiming and can be very self-diagnosing as you see the dot in the window glass. Law enforcement is looked at as professionals and should utilize all tools available to aid them in performing their jobs more efficiently and with greater care to those they serve.

The cost of this upgrade will be approximately one hundred and fifty thousand dollars for the necessary equipment. This will provide the PCSO with everything that is needed for installation of the optics, maintaining proper back up iron sights, duty rated holsters to accommodate the upgrade, and new weapon mounted light switches to accommodate proper holster fit.

This writer personally recommends the use of Pistol Mounted Optics technology for law enforcement. The advantages gained certainly outweigh the costs for the equipment and training. Technology has evolved to give an "industry standard" of reliability and ruggedness that often-made people hesitant to swap to Pistol Mounted Optics platforms. These items, given their implementation, will increase the abilities of the members of the PCSO.




