PUTNAM COUNTY LEGISLATURE CALLED BY THE CLERK AT THE REQUEST OF THE CHAIRWOMAN HELD IN ROOM #318 OF THE PUTNAM COUNTY OFFICE BUILDING CARMEL, NEW YORK 10512

Monday September 29, 2025 5:30 P.M.

The meeting was called to order at 5:33 P.M. by Chairwoman Sayegh who requested that Legislator Montgomery lead in the Pledge of Allegiance and Legislator Addonizio lead in the Legislative Prayer.
